

INFORMATION CONCERNING THE EXERCISE OF THE RIGHT OF WITHDRAWAL

A. Standard instructions on withdrawal pursuant to art.49, paragraph 4, Legislative Decree no. 206/2005 (Consumer Code)

Right of withdrawal

You have the right to terminate the contract, without giving reasons, within 14 days. The withdrawal period expires 14 days after delivery of the first subscription number purchased.

To exercise your right of withdrawal, you must inform us of your decision to withdraw from this contract by means of an explicit declaration (e.g. letter sent by post, fax or e-mail). You can use the attached standard withdrawal form, which is not obligatory. The form, completed in its entirety, must be sent by registered letter with return receipt, or by fax or e-mail, to the following addresses:

In order to comply with the withdrawal period, it is sufficient for you to send the communication concerning the exercise of the right of withdrawal before the expiry of the withdrawal period.

Effects of withdrawal

If you withdraw from this contract, you will be refunded all payments you have made to us, including any shipping costs, without undue delay and in any case no later than 14 days from the day on which we are informed of your decision to withdraw from this contract, but not before receipt of the product(s) ordered and already in your possession. Said refunds will be made using the same means of payment used by you for the transaction, with the exception of payments made by cash on delivery, for which the refund will be made at the Iban coordinates provided.

To take advantage of the refund, please send the goods back to Ass. Aia that raglia bearing the entire shipping costs, without undue delay and in any case within 14 days from the day you have communicated your withdrawal from this contract. The deadline is respected if you return the goods before the expiry of the 14 day period. Aia che raglia will refund you using the payment method used by the User.
